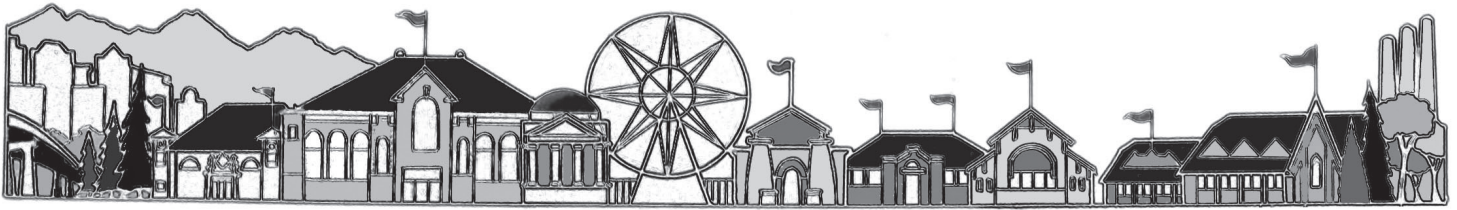

City Prepares for Increased Runoff. North Temple "rocket cones" will help accommodate snowmelt



Public utilities officials want to make residents aware of work now underway to help control expected high spring runoff.

City engineers have been monitoring conditions brought about by a rare combination of heavy winter snow accumulations and the wettest spring on record. High flows are currently present in all Salt Lake City waterways and are likely to continue into early summer months. Residents are reminded to take extra precautions, especially with children and pets, around all creeks, streams, lakes and canals. Fast flows, local flood areas and locations where water has accumulated can be deceiving and hazardous.

Rising temperatures are currently contributing to increased runoff levels. City crews have begun preemptive work to be as prepared as possible for sudden changes in flow rates in waterways and conduits.

Residents and businesses along North Temple will notice that devices have recently been installed on manholes to

help control high runoff. These "rocket cones," currently in place from about 500 West to the Jordan River (1200 West), help the runoff diversion system accommodate a bigger flow of water from nearby mountains into the river. Residents may notice some minor water accumulations around these devices and in other areas along North Temple during the coming weeks as higher temperatures lead to peak runoff conditions. These accumulations will vary according to conditions and will be under constant monitoring by City water crews.

The weather-dependent nature of spring runoff flows can lead to rapid changes in conditions. Residents with questions or concerns can contact the City's Public Utilities Department at 801-483-6860. The City also maintains a 24-hour emergency hotline at 801-483-6700.

FAIRPARK COMMUNITY COUNCIL:

Meeting Minutes for May 26th

Executive committee in attendance: Gordon Storrs, Marialice Jones, Steve Johnson, Brad Hart and Michael Barnes.

- 1 Gordon welcomed everyone.
- 2 Michael B. moved to approve the minutes from April's meeting. Daniel M. seconded, the motion carried.
- 3 Van Turner, City Council District Two, brought news from the City Council. The Mayor's proposed city budget is being reviewed for approval. Van, along with Rep. Jen Seelig, also spoke about the proposed Parole Violator's Facility on North Temple. It appears that the Dept. of Corrections is no longer considering the North Temple location.
- 4 Steve Johnson, representing the Plasma Center Subcommittee that was formed at last month's meeting, talked about the Plasma Center's plans for their property at 600 W and North Temple. The subcommittee met with Neighborworks and learned that the Plasma Center's request to demolish the two story building on the northwest corner of the intersection was denied by the city. A new building to house the Plasma Center will be built to the west of the old building, and a parking area will be created to the north of the old building. Architectural drawings for the new building were available to view. The old building was built in 1912, and is named the Horsely Department Store. It has an interesting history and was placed on the National Historic Register in 2001.
- 5 Shawna Brock, Executive Director of the Independent Living Center of Salt Lake City, along with her colleague Julie Beckstead, spoke about the services provided by them. The center provides information, referrals, advocacy, peer support

and skills training to individuals with disabilities. They provide specialized equipment (walkers, bathroom safety equip., etc.) on a three month loan basis, and also can help folks purchase equipment at a discount. They offer numerous programs to help empower disabled people to live successful and positive lives on their own.

- 6 Detective Gil Arenaz, SLCPD, provided crime stats for the area and discussed a few incidents from last month. He said that bike patrols have been ramped up along the Jordan River Parkway and that the Narcotics Division is busy working in the area parks along the river to try and curb drug activity there. He was available for Q&A.
- 7 Michael Stott, Mayor's Office Liaison, talked about the Mayor's proposed city budget, to be approved by the end of June. The document is available for review on the city's website. Public input is encouraged. He highlighted a few items from the budget including a Good Landlord Program, an enterprise fund for city street lighting costs, a 10% increase

in business license fees, and pay raises for city employees. He mentioned that some groundwork has begun on the Regional Athletic Complex to be built at approx. 2300 N Redwood Rd. The project is tied up in litigation with opposition from environmental groups and will likely go to the Utah Supreme Court. He announced the June 1st groundbreaking ceremony for the city's Performing Arts Center, which is an RDA project and a private/public partnership for a Broadway style theater and office building to be located at 135 S Main St. He announced that the North Temple viaduct should reopen in September. He informed us of a request made by the Jordan Meadows Community Council for lighting at the pavilions at Cottonwood park, and updated us on a request made last month for sidewalks along 600 W between North and South Temple streets. The city is improving the sidewalks on 600 W between 200 S and 300 S, but there is no funding yet for anything further north. He responded to a few concerns: Trains blocking 300 N at 500 W, people said that students from West High School were jumping between stopped train cars on their walks home from school. He said that Union Pacific is working on expanding the train yard further north and that by next fall the trains shouldn't be stopping or backing up across the cross streets anymore. Also there was a question

about enforcement of zoning ordinances regarding unkempt properties, he said the enforcement is complaint driven and the city doesn't have the resources to patrol for these types of offenses. He said the process can seem slow moving because the city tries to help property owners get into compliance rather than just levying fines.

- 8** Captain Healy, Fire Station 7, provided an update and handout that highlighted the services that the Fire Department provides as well response statistics.
- 9** Maria Ginman, property owner at 545 W 500 N and 446 Tuttle Court, came to us with a request for a zoning change for her properties. She and her husband have purchased two apartment buildings and several houses along Tuttle Court, and plan to renovate all of the existing buildings as well as build five new single family homes on the west side of Tuttle Court. The new homes will be two story, 1400-1500 square feet, with attached garages. They are requesting a change in the zoning to allow them to move forward with their plans. There was a lively discussion regarding their plans and intentions. Michael B. made a motion for the Fairpark Community Council to support their plans and recommend our support to the city. Orlan S. seconded, the motion carried.
- 10** Ann P. moved to adjourn, Brad H. seconded, the meeting was adjourned.

Gallivan Center Re-opening, Rescheduled

New, expanded facility will host year-round fun fest

Unexpected delays, due in part to one of the wettest Utah springs on record, have delayed the grand re-opening of downtown's Gallivan Center until July 8.

The Salt Lake Redevelopment Agency originally planned for a June 9 event to signify completion of the expansive, \$8.5 million makeover of one of Salt Lake City's most popular outdoor spaces. The free concert planned for that evening, featuring performances by Ridin' The Fault Line and Sam Bush, will also be re-scheduled to coincide with the new re-opening date.

Other events slated for the month of June at the Gallivan will take place as scheduled, including the Clear The Air Fair on Friday, June 10 from 6-9 p.m., the VivaSLC! Concert on June 11 and Monday Night Movies, beginning on June 20. Details on these and other upcoming activities at the Gallivan can be found [here](#).

The newly renovated Gallivan Center will feature a more user-friendly layout with an expanded grass area for better concert seating and summer picnicking, an updated ice rink system and a new, two-story building that will house banquet space, equipment storage and 45 permanent restrooms.

Salt Lake Redevelopment Agency Director DJ Baxter said the newly refurbished facility, which first opened in 1993 and is named after longtime Salt Lake Tribune publisher and Salt Lake City civic booster, John W. "Jack" Gallivan, will be a much-improved recreation space to be enjoyed by Salt Lake City residents and visitors.

"This project has allowed us to expand and improve the Gallivan Center at all levels," Baxter said. "This urban oasis, which many Salt Lakers consider an extension of their living rooms, will be more attractive, more fun and more useful for everyone who attends the different events and activities that take place there year-round."

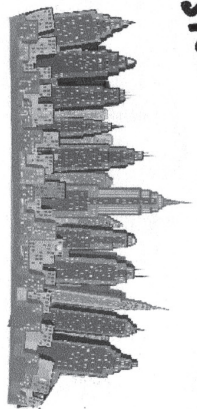
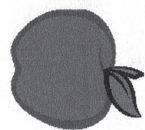
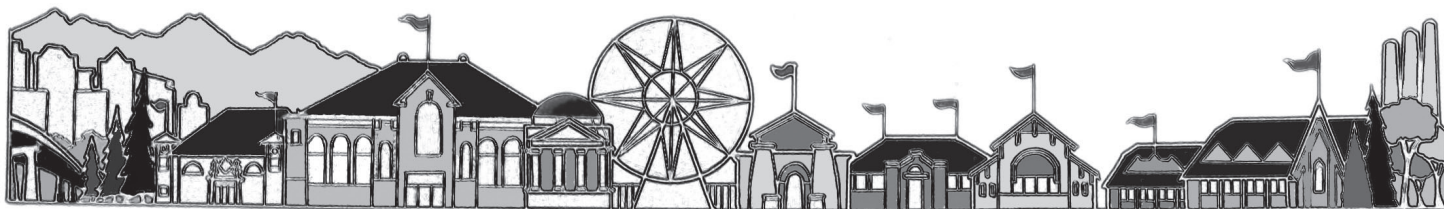
